**I. procedural history**

On February 2, 1996, the Central Puget Sound Growth Management Hearings Board (the **Board**) received a Petition for Review from Baker Commodities, Inc. (**Baker**).

On March 19, 1996, the Board issued a Prehearing Order in this matter.

On May 10, 1996, the Central Puget Sound Growth Management Hearings Board (**the Board**) received a signed "Stipulation and Order of Dismissal" from parties in the above-captioned matter, as follows:

The undersigned attorneys for plaintiff, Baker Commodities, Inc., and for defendant, City of Tukwila, hereby agree and stipulate that plaintiff's claim against defendant has been fully compromised and settled, and that this action may be dismissed with prejudice and without costs.

Based on the foregoing stipulation, the Board enters the following ORDER:

The Petition for Review of Baker Commodities, Inc., in this case is dismissed with prejudice and this Order shall constitute final resolution of the above-captioned case.
