**I. PROCEDURAL HISTORY**

On September 10, 2007, JAMES DAVIES, LOON LAKE PROPERTY OWNERS ASSOCIATION, LOON LAKE DEFENSE FUND, by and through their representative, James Davies, filed a Petition for Review.

On October 10, 2007, the Board held a telephonic Prehearing conference. Present were, Dennis Dellwo, Presiding Officer, and Board Members John Roskelley and Joyce Mulliken. Present for Petitioners was James Davies. Present for Respondent was Peter Scott and Clay White.

On October 15, 2007, the Board issued its Prehearing Order.

On October 16, 2007, the Board upon review of the issues and expected length of hearings, decided consolidation of EWGMHB Case Nos. 07-1-0012 and 07-1-0014 would be appropriate. The Board consolidates the above two cases and provides the following case schedule and listing of the consolidated issues.

1 On October 16, 2007, issued its Order Consolidating EWGMHB Case Nos. 07-1-0012  
2 and 07-1-0014.

3 On January 22, 2008, the Board received a stipulation signed by the parties  
4 requesting a thirty (30) day extension. The parties are currently involved in settlement  
5 negotiations. The Board grants a thirty (30) day extension and provides the following  
6 schedule.

7 On January 22, 2008, the Board issued its Order on Motion for Extension of Time.

8 On February 26, 2008, the Board received Second Motion for Extension of Time  
9 signed by the parties requesting a forty-five (45) day extension. The parties are currently  
10 involved in settlement negotiations. The Board grants a forty-five (45) day extension and  
11 provides the following schedule.

12 On March 3, 2008, the Board issued its Order on Second Motion for Extension of  
13 Time.

14 On April 2, 2008, the Board received a signed Stipulated Motion for Partial Dismissal  
15 and Continuation on Limited Issues. The parties ask the Board for a ninety (90) day  
16 extension.

17 On April 15, 2008, the Board issued its Order on Stipulated Motion for Partial  
18 Dismissal and Continuation on Limited Issues.

19 On July 8, 2008, the Board received Third Motion for Extension of Time signed by the  
20 parties requesting a ninety (90) day extension. The parties are currently involved in  
21 settlement negotiations. The Board grants a ninety (90) day extension and provides the  
22 following schedule.

23 On July 17, 2008, the Board issued its Order on Third Motion for Extension of Time.

24 On September 3, 2008, the Board received an e-mailed Stipulated Motion for  
25 Dismissal. On September 9, 2008, the Board received the signed Stipulation.
